2. With reference to above mentioned Tender Enquiry, the following modifications have been made in tender conditions, which are as under:-

Custom duties will be part of statutory taxes/ duties	Firms stated that this clause is difficult to understand, whether buy-back offer price may be considered while deciding L-1 or otherwise.	It is clarified that if the SPG desires to trade the old item then price offered for buy-back offer will be considered for deciding L-1. However, the bidder has to quote the cost of old item(s) as mentioned under column (I) of revised price bid format.
As per Price Schedule (Annexure-VI): Two formats have been provided to offer the price with buy-back and without buy-back offer for the tender.	Firm(s) has raised query and stated that "Please clarify the price for Buy Back to be offered in which column".	Revised price schedule (Annexure-VI) is enclosed to quote the price for the tender.

3. As per discussions held during pre bid conference on 20.07.2018, certain minor modifications have also been made in the technical specifications. **All the interested bidder firms are requested to collect amended/revised technical specifications from the office of AIG (Tech), SPG, No. 1 Safdarjung Lane, New Delhi-11, accordingly.**
